

SONG DOG KENNELS PURCHASE AGREEMENT

I, _____ have had my interview with _____ of the American Indian Dog breed club founder/caretaker's, SDK or registry on this date: _____.

I have researched this breed, to the extent that I am sure that the American Indian Dog (AI Dog) is the breed for me. I understand that it is a working, primitive type breed that needs exercise and a job to do, within a family or pack situation. In turn, I agree to treat my AI Dog as a respected member of my family and I understand how to be a good Alpha pack leader, teaching my pup with kind, 'respectful', but 'assertive' training; that is recommended for this breed. I will also learn the history and research continually being done on the AI dogs to help educate others on our special breed.

I have enclosed my deposit with a money order or cashier's check of \$425.00, which is one half the purchase price. I understand that my deposit is non-refundable under any circumstances. This is how sure I am that this is the breed I want. I also understand and agree that I cannot breed my American Indian Dog "under any circumstances" and will spay or neuter at or before 6 months of age. I also agree that I will join the IIDOBA (International Indian Dog Owners and Breeders Association) as the fee is included with in the purchase price of my pup or older dog. I will also register my pup (price also included with in the purchase price) with both the American Indian Dog Registry AND the International Progressive Dog Breeders Alliance. Also as a breed club member I will stay in touch with other owners, trainers and founders for new research, training tips or giving advice; through our AI Dog breed club forum over the internet.

I understand I can choose a male or female, but no color preference can be promised, as personality is most important to match owners lifestyle (unless there is a choice of preferred personalities, color should not be most important). I may pass on a litter if the right sex pup is not available, or we as owners are not ready. I fully understand I can pass on a litter if I am unable to take care of a pup or dog for any reason at the time one becomes available. I can remain on the list until I have received my pup or dog until I am ready.

I fully understand that I will spay or neuter my AI Dog or pup and keep the AI Dog registry informed of a change in address.

I agree I will never sell or give away my AI Dog, but will return the pup or Dog to the registry if for any reason I am no longer able to properly care for it. Fully understanding I can be sued unless I return the AI Dog or pup to the founder Song Dog Kennels, registry or appointed agent.
